ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Final Offer Price and Net Proceeds

- The final Offer Price has been determined at HK\$0.32 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$0.32 per Share, the net proceeds of the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$32.0 million. The Company intends to apply such net proceeds in the manner set out in the paragraph “Final Offer Price and Net Proceeds” below in this announcement.

Applications under the Hong Kong Public Offering and the Employee Preferential Offering

- The Offer Shares initially offered under the Hong Kong Public Offer (including the Employee Preferential Offering) have been significantly over-subscribed. A total of 15,279 valid applications have been received pursuant to the Hong Kong Public Offering for a total of 831,260,000 Hong Kong Offer Shares, representing approximately 41.56 times of the 20,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- Due to the over-subscription (by more than 15 times but less than 50 times) in the Hong Kong Public Offering, the reallocation procedures as described in the section “Structure of the Share Offer – The Hong Kong Public Offering – Reallocation” in the Prospectus have been applied and the final number of Offer Shares under the Hong Kong Public Offering has been increased to 60,000,000 Offer Shares (including the Employee Reserved Shares), representing 30% of the Offer Shares initially available under the Share Offer (before any exercise of the Offer Size Adjustment Option and without taking into account any shares which may be issued upon exercise of any options which may be granted under the Share Option Scheme).
- Two valid applications have been received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 400,000 Employee Reserved Shares, representing approximately 0.2 times of the 2,000,000 Employee Reserved Shares initially available for subscription under the Employee Preferential Offering. As the Employee Preferential Offering has been undersubscribed, a total of 1,600,000 unsubscribed Employee Reserved Shares have been made available for subscription by the public under the Hong Kong Public Offering.

Placing and the Offer Size Adjustment Option

- The Offer Shares initially offered under the Placing have been slightly oversubscribed. The final number of Offer Shares under the Placing is 140,000,000 Shares, representing 70% of the Offer Shares initially available under the Share Offer.
- A total of 17 placees have been allotted one board lot of Offer Shares, representing approximately 11.18% of the total number of placees under the Placing. The total of 170,000 Offer Shares allotted to such placees who have each been allotted one board lot of Offer Shares represent approximately 0.12% of the final number of Offer Shares under the Placing after reallocation.
- The Directors confirm that, to the best of their knowledge, information and belief and having made all reasonable enquiries, all allottees of Offer Share under the Share Offer and their ultimate beneficial owners are independent and not connected persons of the Company and any of the Directors, chief executive, Controlling Shareholders, substantial shareholders, significant shareholders or existing shareholders of the Company or any of its subsidiaries, or their respective close associates, and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Offer Shares subscribed by the allottees has been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, substantial shareholders, significant shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the allottees is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, substantial shareholders, significant shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. The Directors confirm that none of the allottees will become a substantial shareholder of the Company within the meaning of the GEM Listing Rules immediately after completion of the Capitalisation Issue and the Share Offer and there will be at least 100 Shareholders at the time of the Listing in compliance with Rule 11.23(2) of the GEM Listing Rules, and the three largest public Shareholders will not beneficially own more than 50% of the Shares in public hands at the time of the Listing in compliance with Rule 11.23(8) of the GEM Listing Rules.
- The Offer Size Adjustment Option has not been exercised by the Joint Bookrunners (for themselves and on behalf of the Placing Underwriters) and has lapsed.

Shareholding Concentration Analysis

- The top 25 Shareholders (including IWS BVI) in aggregate held 676,940,000 Shares immediately upon completion of the Capitalisation Issue and the Share Offer, representing 84.62% of the then entire issued share capital of the Company.

Based on the final Offer Price of HK\$0.32 per Share, the net proceeds of the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer (“**Net Proceeds**”) is estimated to be approximately HK\$32.0 million.

We intend to apply the Net Proceeds in the following manner:

- approximately 45.3% of the Net Proceeds or approximately HK\$14.5 million, will be used for expanding our business in security services by (i) providing contract securities; (ii) recruiting security service personnel; and (iii) acquiring patrol vehicles to undertake new contracts;

Two valid applications have been received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 400,000 Employee Reserved Shares, representing 0.2 times of the 2,000,000 Employee Reserved Shares initially available for subscription under the Employee Preferential Offering. As the Employee Preferential Offering has been undersubscribed, a total of 1,600,000 unsubscribed Employee Reserved Shares have been made available for subscription by the public under the Hong Kong Public Offering.

No application has been rejected due to bounced cheques. No application has been identified for not having been completed in accordance with the instructions on the Application Forms. 12 multiple applications or suspected multiple applications have been identified and rejected. No application for more than 18,000,000 Hong Kong Offer Shares and/or 2,000,000 Employee Reserved Shares have been identified.

Due to the over-subscription (by more than 15 times but less than 50 times) in the Hong Kong Public Offering, the reallocation procedures as described in the section “Structure of the Share Offer – Hong Kong Public Offering – Reallocation” in the Prospectus have been applied and a total of 40,000,000 Offer Shares have been reallocated to the Hong Kong Public Offering. After reallocation to the Hong Kong Public Offering, the final number of Placing Shares allocated to 152 placees under the Placing is 140,000,000 Placing Shares, representing 70% of the total number of Offer Shares available under the Share Offer.

In connection with the Share Offer, the Company has granted the Offer Size Adjustment Option to the Joint Bookrunners, exercisable by them (for themselves and) on behalf of the Placing Underwriters at any time from the date of the Placing Underwriting Agreement until 5:00 p.m. on Friday, 18 October 2019, to require the Company to issue and allot up to an aggregate of 30,000,000 additional Shares at the Offer Price to cover over-allocations in the Placing, if any. The Offer Size Adjustment Option has not been exercised by the Joint Bookrunners (for themselves and on behalf of the Placing Underwriters) and has lapsed.

A total of 17 placees have been allotted one board lot of Offer Shares, representing approximately 11.18% of the total number of placees under the Placing. The total of 170,000 Offer Shares allotted to such placees who have each been allotted one board lot of Offer Shares represent approximately 0.12% of the final number of Offer Shares under the Placing after reallocation.

A total of 53 placees have been allotted three board lots of Offer Shares or less, representing approximately 34.87% of the total number of placees under the Placing. The total of 1,240,000 Offer Shares allotted to such placees represent approximately 0.89% of the final number of Offer Shares under the Placing after reallocation.
